HOW TO BUY AND IMPORTANT TERMS & CONDITIONS:

VIEWING of the items (motor vehicles) can be done at the **AUCTION LOCATION** to verify the condition of the items for sale, as these are not warranted by the Auctioneer or UNHCR.

- **SALE WILL BE ON "AS-IS-WHERE-IS-BASIS".**
- **ALL BUYERS MUST REGISTER & PAY A REFUNDABLE DEPOSIT IN ADVANCE TO PARTICIPATE.** Buyer Registration, issuance of bidding numbers & catalogues is at

AUCTION LOCATION in KIGALI RWANDA at UNHCR Logistics Base - ADRA YARD GIKONDO Industrial Park, former (GTZ) WAREHOUSE opposite BANDAG,

From 13th to 17th of NOVEMBER, 2017 from 09:00 AM to 16:00 PM and will continue on the auction day of the 18th of NOVEMBER, 2017 from 08:00 to 10:00 AM.

- **BIDDING AND DEPOSITS**
- You must have bidding number to participate in the auction. Interested buyers are required to pay a **refundable deposit of RWF 851,500** (equivalent to \$1000) for the vehicles & heavy equipment and / or **RWF 426,000** (equivalent to \$500) for other small items. The registration should be paid directly to the Best Group International Ltd. and is refundable at the gate after the auction, if the bidder does not buy any goods from the auction.
- PAYMENTS for all purchases must be in form of DIRECT DEPOSIT to the announced bank accounts at the Auction Yard.
- The declared buyer will have to pay **25%** of the purchase price by the end of the AUCTION DAY and the remaining **75%** shall be paid **within 3 days** after auction (latest by **22nd November 2017**). Failure to pay the **75%** within the given deadline of 3 working days after the auction, will make the **deposit** forfeited and the property will be re-auctioned.
- The declared buyers deposit will be immediately applied to the purchase price and become a part of the 25% deposit and will **NOT BE REFUNDED**. No second bidder will be taken into consideration.
- **Sale is subject to reasonable reserved prices.**
- All expenses and cost in respect of taxes and dues shall be borne by the buyer. **Please note that all motor vehicles were originally duty and tax exempted, hence it is the obligation of the buyer to make sure he/she pays all taxes and dues within seven days after paying 100% sales price.**
- **In case the buyer does not clear the taxes in the period defined** (maximum 14 days after the auction) the buyer will be charged for extra storage fee within the subsequent 7 days. After this period all Vehicles fully paid but not claimed for, will be towed-away at extra charges for the buyer.
