Umutungo uzatezwa cyamunara uherereye mu muji wa Kigali, Akarere ka Nyarugenge, Umurenge wa Gitega.

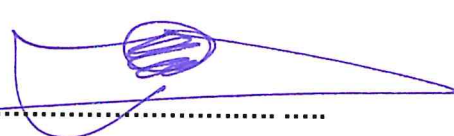
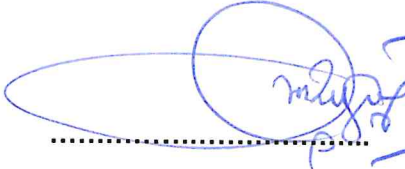
